

**Minutes of the Annual Meeting of the Stow Bardolph Parish Council  
Held at Stow Bridge Village Hall on Tuesday 12<sup>th</sup> July 2022**

**1. To elect a Chairman**

1.1 In the absence of both the Chair and the Vice-Chair, Cllr Cooke proposed Cllr Hudson be elected as Chairman, seconded by Cllr Bishop and unanimously agreed by all present.

**2. To receive apologies for absence**

2.1 Apologies were accepted from Parish Cllrs' Mr W Esse, Mr Derek Barnes and Mr Mark Brighton.

**3. To receive any declarations of interest in items on the agenda**

**4. To approve and sign the minutes of the meeting held 10<sup>th</sup> May 2022**

4.1 The minutes of the meeting were approved without amendment and signed by the Chairman as a correct record.

5.1 All matters that the Clerk has been working on are covered by the agenda.

**6. To receive updates from Borough and County Councillors**

6.1 Cllr Rose had sent a report ahead of the meeting but reiterated the urgent need for support for the Queen Elizabeth Hospital to be replaced with a new building. Cllr Rose also thanked those communities that had invited both him and Cllr Spikings to their Jubilee events.

**8. To discuss any Highway Matters**

8.1 A report on all previously reported issues had been circulated to Members ahead of the meeting (and is attached at appendix ii).

8.2 No new issues were reported.

8.3 Wimbotsham Parish Council will be re-applying to the CIL Fund for a grant towards the proposed Trod between Wimbotsham and Stow Bridge; they have requested help in obtaining letters of support from the local community. The Clerk will forward details to Council Members, who will approach local residents and businesses with this request.

8.4 Parish Partnership Funding is available again this year and could be a source of match funding for the Trod and will therefore be reviewed later in the year, when the outcome of the CIL application is known.

10.1 The Council noted the results of previous applications and the responses from the Planning Advisory Group to applications received for consultation since the last meeting (see report attached to July 2022 agenda).
