Minutes of the Annual Meeting of the Stow Bardolph Parish Council Held at Barroway Drove Village Hall on Tuesday 16th May 2023

The meeting commenced at 7.30pm

1. To elect a Chairman and Vice-Chairman

- 1.1 Mr W Esse proposed that Mr D Barnes be elected as Chairperson, seconded by Mr R Hudson; all present voted in favour of the appointment. Mr Barnes accepted the position and duly signed the Declaration of Acceptance of Office.
- 1.2 Mr R Hudson proposed Mr W Esse be elected as Vice-Chairperson, seconded by Mr M Brighton; all present voted in favour of the appointment. Mr Esse accepted the position and duly signed the Declaration of Acceptance of Office.

2. To receive apologies for absence

2.1 Apologies were accepted from Parish Councillor's Mrs S Dent & Mrs S Clanfield, Borough Councillor Mrs V Spikings and County Councillor Mr C Dawson.

3. To receive any declarations of Interest in items on the agenda

3.1 Cllr Barnes declared and interest in Planning Application 23/00500/F (agenda item 10a).

4. To approve and sign the minutes of the meeting held 14th March 2023

4.1 The minutes of the meeting were approved without amendment and signed by the Chairman as a correct record.

5. Clerk's report (for information only)

5.1 All matters that the Clerk has been working on are covered by the agenda.

6. To receive updates from Borough and County Councillors

- 6.1 Cllr Rose reported that roles and responsibilities of the newly elected Borough Council Members were still being finalised and he would be able to update with more details in due course.
- 6.2 Cllr Dawson was not present but had sent details of a proposed new car parking space and path next to Morton's Bridge; the Member's present were in support of this proposal.

7. Open Forum for public participation

7.1 There were no comments or questions from members of the public.

8. To discuss any Highway Matters

8.1 A list of all current Highways issues within the parish was reviewed and agreed and is attached at appendix i; the Clerk will ensure these are reported to NCC Highways Dept and an update on responses will be provided at the next meeting.

8.2 Correspondence regarding lack of suitable access (dropped kerb) across the new footpath in Barroway Drove was reviewed; It was agreed that this matter will be discussed again when the invoice for this project is received.

9. To discuss any Street Light Matters

9.1 No faults were reported.

10. To discuss Planning Matters

- 10.1 The Council noted the results of previous applications and the responses from the Planning Advisory Group to applications received for consultation since the last meeting (see report attached to May 2023 agenda).

12.1 As per the current insurance arrangements (3-year agreement with Gallagher) the schedule and premium for the coming year were reviewed and approved.

13. To review the Clerk's Job Description and Contract of Employment

- 13.1 The Clerk's Job Description was reviewed and agreed without amendment.
- 13.2 Minor changes to the wording of the Clerk's Contract of Employment were agreed, along with updates to the Annual Leave Allowance, in line with the NJC agreement on pay and conditions; the Clerk and the Chairman then signed an updated copy of the Contract.

14. To review the Council's Standing Orders

14.1 The Council's Standing Orders were reviewed and section 18 was amended in line with recommendations from the National Association of Local Councils.

15. To review the Council's Grant Making Policy

15.1 To Council's Grant Making Policy was reviewed; no amendments were made.

16. To discuss and agree Finance Matters

16.1 The Council **RESOLVED** to accept the year-end financial report and bank reconciliation as a true record of the Council's financial transactions for 2022-23

- 16.2 The Internal Audit had been completed by Mapus Smith & Lemmon Accountants, who confirmed that correct accounting procedures had been followed throughout the year; the Council **RESOLVED** to accept the Internal Audit Report.
- 16.3 The Council agreed that it met the criteria to declare itself exempt from review by the External Auditors; the Chairman thereupon signed the Certificate of Exemption.
- 16.4 The Council **RESOLVED** to approve the Annual Governance Statement. The Chairman signed the Annual Governance Statement section of the Annual Governance and Accountability Return (AGAR) on behalf of the Council.
- 16.5 The Council reviewed the Accounting Statements. The Council **RESOLVED** to approve the AGAR Accounting Statement. The Chairman signed the Accounting Statements section of the AGAR on behalf of the Council.
- 16.6 The council **RESOLVED** to approve the updated Asset Register.

- 17.2 Cllr Hudson proposed that Mr Richard Gilbert, having met the necessary criteria, be coopted to serve as a Member of the Council; this nomination was seconded by Cllr Brighton and agreed by all present. Mr Gilbert accepted the office, duly signed a Declaration Acceptance and joined the meeting.
- 17.3 Cllr Barnes proposed that Mr David Brighton, having met the necessary criteria, be co-opted to serve as a Member of the Council; this nomination was seconded by Cllr Esse and agreed by all present. Mr Brighton was not present at the meeting but had indicated his willingness to accept the position, therefore he will be summoned to attend the next meeting.
- 17.4 The Clerk will complete an induction with both new Councillors ahead of the next meeting.

18. To discuss correspondence two items of correspondence

18.1 The Council reviewed correspondence regarding the Royal British Legion Cycling Event, taking place in June, and RESOLVED to make a donation of £30, as all proceeds will go to their Poppy Appeal, and will benefit local people.
